42(b)GSDL Constitution - Any member residing a minimum of 100km or more from the GPO as registered in the electoral role must register their request and signed by the member registering for a postal vote with the secretary and the request shall be dealt with by a simple majority vote at the General Meeting one month prior to the AGM. A stamped and addressed envelope to that member must be enclosed with such a request and a member who has so registered and accepted shall be called "a postal voting member".
